1- Application for space on the Exhibition shall be made on the form overleaf and shall be duly signed by the Exhibitor or a person authorized by him. Following receipt of the Application together with initial payment. the Organizer reserve the right to refuse any Application at their absolute discretion without necessarily giving the reason for such refusal, all special decoration must be approved by the organizer and must not exceed the height of 280cm, and must provide electrical cable 7 m length minimum.

2-the payment schedule for space only, shell stand or furnished stand is as follows:

application is made after the final payment date specified on the Application, the total shall be path with the Application The total price represents only the payment for the space, details of which are set out overleaf. 4. in the event the organizer agrees to a cancellation of the space contract. the Exhibitor will be liable for all, or part of the contract price depending on when the cancelation request was received and acknowledged: if 90 days prior to the exhibition's opening date 50% OF Total amount if 30 days prior to the inhibitions opening date 100 of total amount if within 30 days prior to the exhibitions opening date more OF TOTAL Auburn The date of the cancellation request is the one on which the Organizers receive written notice by courier or far. And ac knowledge receipt of same to the Exhibitor. in addition to the cancellation charges, the Exhibitor will be liable for any specific consequent noun incurred on the Exhibitor's behalf by the Organizers.
